

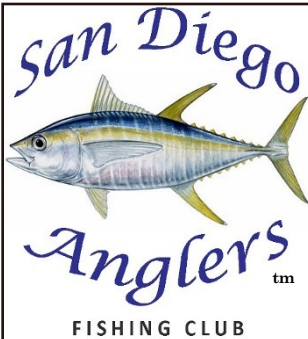

2020 October Bass Slam Tournament

For the month of October we are going try to a ONE-DAY, LIVE Weigh-in-type tournament. The tournament will be on **Saturday, October 17th, 2020**, with a starting time of 6:00 AM and end time will be at 4:00 PM. The **San Diego Anglers Weigh in Station located at the Shelter Island Boat Ramp. Weigh in will begin at 3:00 PM and close at 4:00 PM.** We are going to try a one-day, live weigh-in tournament because the biggest challenge to this tournament is catching one of all three species in one day. So if you think you know where these three different kinds of bass hide out, let's get out there and show us just how good you are. The fishing areas are limited to those waters of the Pacific Ocean within 125 miles of San Diego. We will have the two categories of anglers with prizes: Adults 1st thru 5th place prizes and Juniors, with 1st thru 3rd place, prizes. In looking at the tides for the day of the tournament we have a Low tide at 3:40 AM, 0.4 feet; High tide at 9:53 AM, 7.0 feet; and the next low will be at 4:27 PM, -0.7 feet. So we should have two good tidal flows. According to TIDES4FISHING there will be 3 good times for fishing this day, with the first time listed at 8:00 AM 3 fish, at 1:45 PM 3 fish, and 3:00 PM another 3 fish period. Keep in mind that the weigh-in will be from 3:00 PM to 4:00 PM at the Shelter Island Boat Ramp on San Diego Bay. We will have a canopy and scale set up in the grass area next to the boat launch entry. There will be food and beverages at the weigh-in, I hope. We have to look at the COVID-19 requirements to see how we can do this. We are looking forward to seeing as many of you as possible in the tournament.

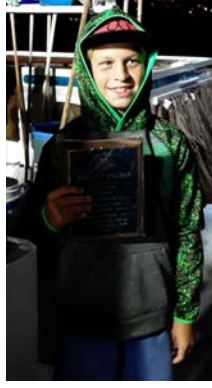

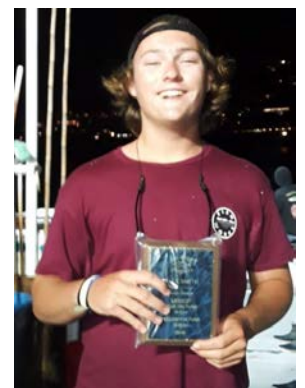

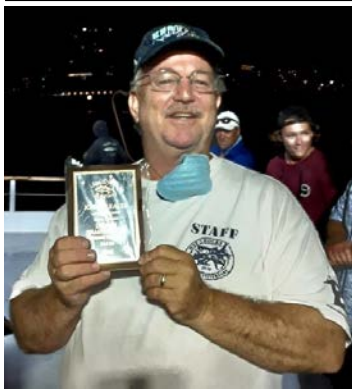

2-day "Liberty" Charter Trip Report

21 anxious people gathered early at Fishermans Landing in anticipation on getting in on the hot fishing that had been happening at outside San Clemente Island; limit style Bluefin from 25 to 100lbs were being caught with regularity. Captain Taro gave his seminar as we headed out, recommending bait sticks from 25lb to 40 lb and a rubberband sinker rig on 50 or 60 lb and a Flatfall rig of 80 or 100lb for nighttime lunker fishing. He also told us to sleep in as the fish would not be biting well early in the morning. We got to the grounds just after daybreak and joined the group of boats that were already searching. A few spots of breaking bluefin would pop up every once in awhile in the morning and we would get a brief shot at them, hooking and landing a few fish. Finally about 2 pm the fish started to pop up, boiling on all the anchovies that were in the area. All the boats were running and gunning on the fish, but for the most part the fish would sink out as we got there. We would get lucky and pick off a few but we , like the rest of the fleet that day, just chased those pesky bluefin. At one point I was in the wheelhouse with Taro and we could see fish all around us in different schools, but by the time the boat got pointed in that direction, they would sink out. We should have been there yesterday!!! We went into the night in much anticipation of a good flatfall bite. We did run into a few schools at 180 to 250 ft, but they did not want to play. We did catch a few but had to quite about 10 pm so we could travel on down to the yellowfin tuna grounds that was biting southwest of San Diego.

We woke up to beautiful seas and an awesome red sunrise from the smoke inland. We started to pick off a few fish in the morning, with light line and little hooks being the ticket. Cast a bait to where they were throwing the chum seemed to be the best bet for a bite. "Change your bait" was the mantra that was echoed all day as a bait that was 45 seconds old would not be bit with regularity. We finally found a school that wanted to play by midafternoon and it was game on. They bit for us for an hour or so and we put the bulk of the fish on the boat at that stop. When they stopped, we kept searching but did not find another school that wanted to play like that. We turned the pointy end of the boat towards home in flat seas, and talked about our fun trip. We would like to thank Captain Taro and his great crew, Enible, Paul, Ryan, Taylor and Sarah, for another fun trip!! Can't wait until next year!

Limited load of 30, and the cost will be \$180. And as with all charters this year, masks are required to get on the boat. We will be expecting tuna, dorado and yellowtail offshore. Light line, 20lb test, and small #4 hooks have been the ticket again this year, so please be sure to include one of these sticks in your arsenal.

Warriors on the Water September 2020 Charter on the “Liberty”

We ended our WOW trips this year once again on the Liberty out of Fishermans Landing. Last year's trip was fantastic as Captain Taro took us tuna fishing just outside the islands and we thought we would never see a better trip, but this one we had in Sept certainly was on par with it!

A decision was made to get the permits and go to the Coronado Islands as Taro had been coming through the islands for the last few days coming home from dorado fishing and he liked what he saw: good conditions, yellows and bonito splashing around. The 30 warriors from the Freedom Station and the Aspire center (PTSD) were there early at Fisherman's landing (like 4:30 am) for a 5:30 departure. Passports were collected and the permits obtained, and we were off in record time. On the way down, Chad and Frank from Hookup Baits were busy preparing the 35 spinning rods we brought just to fish Hookup Baits, not knowing the day that was coming. The rest of the volunteers were tying on hooks on the loaner gear from Fishermans that was donated.

After a short ride down to the islands, we were ready to go. We stopped at North Island, threw some chum, and the water erupted in boils of yellows and bonito. The Hookup Baits crew went to the front of the boat and started hooking and handing almost as fast as the baits were hitting the water, and the live bait guys were feeding their sardines into the mayhem that was happening in the chum line. The guys were flying around the boat trying to follow the bonito and yellows that were jumping on the hooks like there was no tomorrow. The dust finally settled about 30 minutes later and it is safe to say that almost everyone had fish in the sack. We did not move very far before it repeated and at that point everyone had fish in the sack and the guys were already exchanging fish recipes!

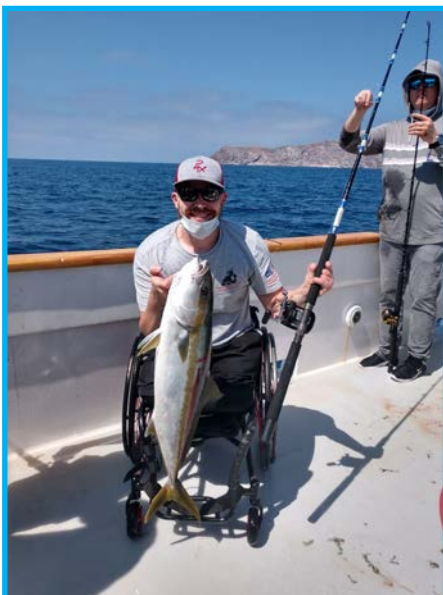
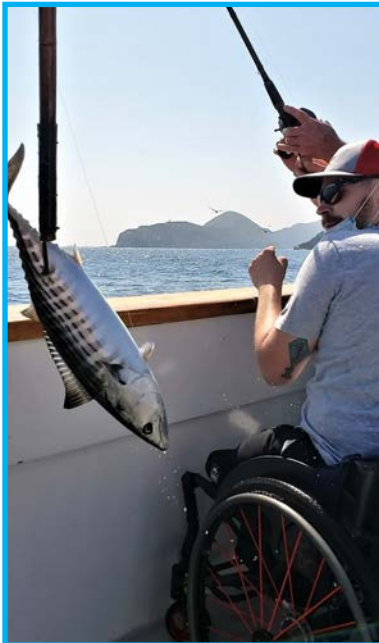
This went on all day long, moving from spot to spot as the fish bit for us all day, which is very unusual. We got into a rhythm as if you wanted to catch a yellow on a Hookup Bait (1 oz mint) you went to midship or the bow, cast it out, let it sink for a bit and wound your fish in. If you wanted to fish a sardine, go to the back, get a fresh bait beyond the sealions and, hook another yellow, bonito or bass. As we fished our way down the islands, we ran into schools at every stop, making the sacks heavier and heavier. We ended up the day south of South Island a few miles, at South Kelp Ridge where we found Bluefin Tuna willing to boil on our chum. A few lucky ones were able to connect and get the prized bluefin in the boat if they could get their bait through the calicos that were eager to eat that lively sardine as it was zooming toward the bluefin that were jumping around outside. We ended the day by having one of the guys deciding to toss a Hookup Bait out the back of the boat on 12 lb test and hooking a Bluefin right away. We watched as the tuna took off on the surface, emptying the little spinning reel of all of its line. When it reached the knot, it broke off, just like we thought it would, but the angler had the thrill of a lifetime and a story to tell when he got home!

We turned the nose toward home in beautiful seas and started cleaning fish soon after. The guys were on cloud nine as they never expected such an exciting day, all telling stories as we headed home. We had so much fish, and the boat being so fast, that we had to finish cleaning the fish in the harbor outside the entrance to the basin. We backed the boat into the slip, and Club President Ray Broadfoot did his Thank You presentation from the upper deck, thanking the warriors for their service and the sponsors for making it happen. The fish was unloaded to the top of the dock, lots of hands were shook, and the warriors took off for home with GIANT smiles on their faces!

We would like to thank all the sponsors for making it happen: Fishermans Landing and Liberty Sportfishing for cutting us a deal on the boat and donating the tackle, Past SDA Board of Director Dave McMullen from Ocean Science Foundation for his yearly cash donation, Bill Van Wulven from Barnacle Bill's Tackle shop for the sunglasses for the warriors, Jim on Crystal Pier for buying the Mexican Permits, Chad, JoJo and Frank from Hookup Baits for supplying the Hookup Baits and the smiles that went along with every hookup, and last but not least, Josh and Ralph from Penske Ford in La Mesa. 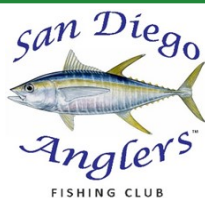

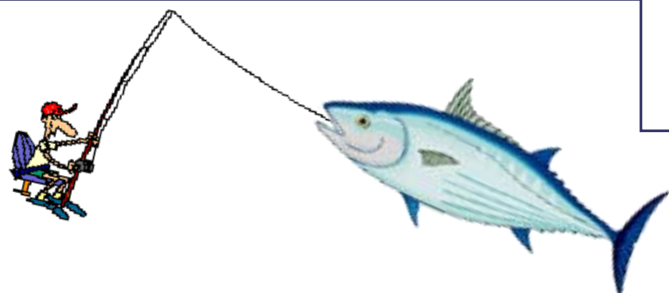

OCTOBER 2020 BASS SLAM TOURNAMENT RULES AND ENTRY FORM

Saturday, October 17th, 2020



The official starting time of the tournament is 6:00 AM on Saturday, October 17, 2020. The official ending time of the tournament is 4:00 PM on Saturday, October 17th, 2020. **THIS WILL BE A LIVE WEIGH-IN TOURNAMENT.**

NOTE: All State and County COVID-19 Directives must be adhered to.

- Boats may depart prior to the official starting time of the tournament. Boats must depart from and return to any port within the county of San Diego. No tournament fishing is allowed prior to the official tournament starting time. All club tournaments are operated on an honor system
- The fishing areas of the tournament shall be limited to those waters of the Pacific Ocean within 125 miles of San Diego.
- During the tournament, fishing can be done from any fishing platform, including Sportfishing boats.
- Bait may be caught, purchased, or acquired as available prior to the official tournament starting time. Bait may be kept aboard tournament boats, used, or transferred at the discretion of the anglers or skippers throughout the tournament.
- IGFA angling rules will be used for this tournament. Angling rules can be found in the San Diego Anglers Yearbook under General Angling Rules. Anglers are responsible for compliance with all California or Mexican fishing and boating laws and regulations, as applicable.
- All fish must be weighed in on the Club Scale between 3:00 PM and 4:00 PM at the San Diego Anglers Tournament Weigh Station at the SHELTER ISLAND BOAT LAUNCH RAMP on San Diego Bay.
- Eligible Species: Calico Bass, Sand Bass, and Spotted Bay Bass. Entrants can weigh in only one fish from each species, per day of tournament. Only your heaviest fish of each specie will count toward your 3-fish sack, with only one sack per registered angler.
- Prizes will be awarded in the following categories: heaviest Sack Weight - 1st, 2nd, 3rd, 4th and 5th place for adults; 1st, 2nd and 3rd for juniors. Regardless of weight, 3-Bass sack beats a 2-Bass Sack and a 2-Bass Sack beats a 1-Bass Sack. There will be no ties in any category. When two sacks of the same weight are submitted, the first sack submitted is considered the winner. Tournament awards will be presented at the NEXT club meeting.
- Jackpot:** There will be a \$10.00 optional Jackpot for the LARGEST single fish from any of the Bass species.
- All anglers are responsible to be aware current weather/sea conditions. Monitor NOAA weather radio for info.
- All tournament anglers must complete, sign and submit a Tournament Entry Form and a COPY OF THEIR CURRENT BOAT INSURANCE POLICY prior to wetting a line in this fishing tournament. Entrants may sign up anytime prior to the tournament starting date and time. The entry forms must be turned in to the locations or persons listed on the back of this form. All entrants in the tournament must be current members in good standing or non-members fishing as a guest of a club member. Entry forms can be scanned and emailed to Tournament Director with all pertinent signatures, boat insurance info (if applicable), and date/time stamp. By signing the application, Applicant does assume all risks of injury or property damage, and does agree to hold the San Diego Anglers harmless should any injury, death or property damage occur.
- Failure to comply with any of these rules will result in the offending angler's disqualification from the tournament and possible termination of club membership.
- Tournament Angler of the Year and Skipper points will be awarded for this tournament.
