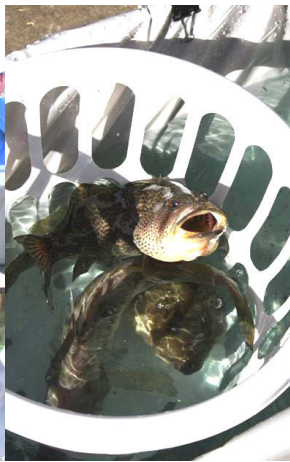
Congratulations to club member Tony Souza for winning the Bay Bass Tournament this year!!! After a beautiful sunrise, the 142 boats and kayaks all took off for their secret spots to get a crack at the \$2000 first place prize sponsored by Doug Kern at Fisherman's Landing Tackle. We upped this years first prize to \$2000 to make the 20th Annual event a little more special! We had heard that the prefishing had been a little tough and the anglers were happy that we had dropped the team limit from 5 fish down to 3 fish this year. The boats and kayaks started to show up about 12:30 and our crews were ready to go. The BBQ's were hot, the beer was cold and the weigh station was just getting warmed up as the 3 fish limits started to show up. There were lots of 3 fish, 14'' bass coming across the scales with mere hundredths of a pound separating many of the contestants. The big excitement was when Rodney Thompson showed up with a 19 lb halibut hoping that no one else was going to weigh a bigger one. And true to form, all the bigger limits started to show up the last 15 minutes of the weigh in and when the dust settled, Tony Souza was the big winner! His 3 fish weighed 8.2 lbs and netted him \$3650 plus Daiwa Lexa 300 reels and matching rods!! Here is a list of the top five spots.

This has happened a few times in the past where the winner did not get into the jackpot side pot!!

New Laws Affecting Fishing

As if we didn't have enough laws and regulations to follow and obey. It seems the legislators in Sacramento have been busy trying to justify their salaries with useless laws and regulations that will directly impact our fishing. Here are just a few of the laws going into effect January 1, 2015.

Vessel Operator Permit: The law becomes effective Jan. 1, 2015, but by Jan. 1, 2018, California's Division of Boating and Waterways (Cal Boating) must develop a vessel operator education program that applies exclusively to operators of engine propelled vessels. Once the program is fully developed by 2018, the requirement to pass an exam and obtain a Vessel Operator Card would be phased in within eight years. In addition to developing regulations, Cal Boating would also be allowed to establish a fee for the operator card.

Live Freshwater Bait Fish License for Retail Live Bait Outlets: The law becomes effective Jan. 1, 2015. It will require all live bait outlets to issue a live freshwater bait fish license when specifically selling live freshwater fin fish and crayfish for use in inland waters. The license must also list the specific location of where it is issued.

Recreational Pacific Halibut Allocation Increase: This law really does not affect us much since we only have California Halibut off our southern California coast. But those members that like to fish in Alaska for the Pacific Halibut. It appears that the allocation or yearly quota for Pacific Halibut is going down in Oregon, Washington and Alaska to make up for increase in the yearly quota given to northern California.

Pacific Bluefin Tuna Management: This is one law that is going to affect most of us for the upcoming summer. Fishing for Bluefin tuna in the Pacific Ocean will become more restrictive in 2015, as federal and state agencies drastically reduced the number of Bluefin tuna anglers can catch in a day. Specifically, the Pacific Fishery Management Council adopted a 2 fish per day limit, no more than a total of six Bluefin on multi-day trips on the predatory and migratory fish species found between Japan and the western United States. The previous daily limit was 10 fish per day. The catch limit is in effect for the 2015 and 2016 fishing seasons. Also, filleting of tunas at seas is still permissible, though with specified restrictions. Make sure to get the new CDFW saltwater handbook at your local tackle shop.

1. The official starting time of the tournament is **6:00am on Saturday, February 21th, 2015**. The official ending time of the tournament is **3:00pm on Saturday, February 21th, 2015**.
2. Boats may depart prior to the official starting time of the tournament. No Tournament fishing is allowed prior to the Tournament official starting time.
3. **The fishing areas of the tournament shall be in MISSION BAY (Drawing an Imaginary line between the entrance/exit jet-ties) Fishing maybe done from any platform including Sports/Guide boats. No fishing within 100ft of Bait Barge.**
4. Bait may be caught, purchased or acquired as available prior to the official tournament starting time. Bait may be kept aboard tournament boats, used or transferred at the discretion of the anglers or skippers throughout the tournament.
5. California Department of Fish & Game regulations will be used for this tournament. IGFA angling rules apply, **No exceptions**. Angling rules can be found in the San Diego Anglers Yearbook under General Angling Rules. Anglers are responsible for compliance of California and Mexican, fishing and boating laws/regulations.
6. Transferring of anglers and fish from a disabled boat is allowed to comply with rule #7 or to continue to fight a hooked fish.
7. Anglers must report in person with the Tournament Weigh master with their fish ready for weighing no later than the official ending time of the tournament.
8. **Species: HEAVIEST ANY COMBO BASS SACK: Calico bass, Sand Bass, & Spotted Bay Bass.** (\$5.00 Optional jackpot for heaviest single bass). **All fish must be weighed on the Club scale between 2:00pm & 3:00pm at the San Diego Anglers Tournament weigh station located at the SOUTH SHORES LAUNCH RAMP LAWN AREA next to the restrooms.**
9. **Prizes will be awarded in the following Categories: HEAVIEST ANY COMBO BASS SACK of Calico/Spotted/Sand Bass (3 fish sack). 1st, 2nd, 3rd, 4th and 5th place for adults based on participation; 1st, 2nd and 3rd for juniors. There will be no ties in any category. When two sacks of bass of the same weight are submitted, the first sack weighed is the winner.**
10. All anglers are responsible to stay aware of current weather/sea conditions. Monitor NOAA weather radio for info.
11. **All tournament anglers must complete, sign and submit a Tournament Entry Form prior to wetting a line in this fishing tournament and complete Boat Insurance Info on back of entry form prior to fishing the tournament including the policy's ending date and time. NO VERBAL ENTRIES INTO TOURNAMENT ACCEPTED.**
12. **The entry forms must be turned into the locations or persons listed on the back of this form by 5:00pm, Friday February 20th with the Tournament Director or Fisherman's Landing Tackle Shop.** All entrants in the tournament must be current members in good standing or non-members fishing their first introductory tournament as a guest of a San Diego Angler club member. Entry forms can be scanned and emailed to Tournament Director (Dave Hanes) with all pertinent signatures, boat insurance info if applicable, date and time stamp. By signing the application, applicant does assume all risks of injury or property damage, and does agree to hold the San Diego Anglers harmless should any injury, death or property damage occur.
13. Failure to comply with any of these rules will result in the offending angler's disqualification from the tournament and possible termination of club membership.
14. **Tournament Angler, Angler of the Year and Skipper points will be awarded for this tournament.**
